John and I feel that is important for both Patrick and Andrea to be able to visit. Andrea often talks about Patrick and says how much she loves him and misses him. We tell her that Patrick knows she loves him and misses her too. We also tell her that Patrick loves her too and wants her to get better. When she is hallucinating she will often talk to Patrick and relives things they have done in the past.

We have always said that Patrick could visit his mom. We know how important they are to each other. We have allowed Mark Wampler, a family friend and John Ansman, Patrick's grandfather to bring Patrick for visits. We were not there during these visits but one of Andrea's aunts, Judy Hayes, was there. She encouraged Patrick to come up to Andrea's bed. She told Patrick some stories about how Andrea talks about him and to him when she is remembering things that have happened. Anytime they wish to bring Patrick back for another visit they are welcome.

We do not want to allow her husband, Chris Ansman, to visit with Andrea. We feel that it is not in her best interest at this time. If Chris wishes to bring Patrick to the hospital so that Patrick can visit, that would be fine. We could meet Patrick at the elevator and take him to the room for a visit. Chris could wait there and we would bring Patrick back when the visit was over. There are several people who stay with Andrea so in order to facilitate this we would need some prior communication. If Chris could let us know the day before a general idea when he was coming we could let him know whom to text when he was getting on the elevator. We would also be sure to have our phone handy and be watching for the text. If Chris does not feel comfortable with his, and would rather Mark or John bring Patrick that is fine, too.

We understand that it is good for both Andrea and Patrick to see each other. We would like to see him visit her as often as he can.
