It is hereby Ordered and Adjudged:

The Petition of Patrice Hayes to become Successor Guardian is DENIED;


The Petition of William Christopher Ansman (hereinafter, Chris Ansman) to become Successor Guardian is CONTINUED;

The Guardian:

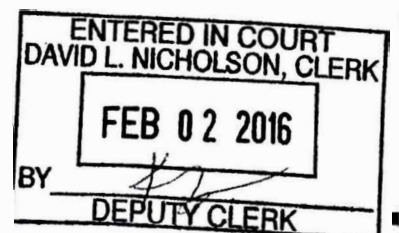
- 1) Is to allow unrestricted access of Ward to Ward's spouse, Chris Ansman. This includes, but is not limited to, Mr. Ansman's ability to remove the Ward from her treatment facility as long as the removal does not interfere with the Ward's treatment.
- 2) Is to allow Chris Ansman unlimited access to all medical information regarding the Ward, including diagnosis and treatment information both past and present. Chris Ansman should be allowed the opportunity to transport and participate in the Ward's doctor's appointments.

The Court further orders a Social Worker visit by a Court Appointed Social Worker. The purpose of this visit will be for the Social Worker to assess the Ward's physical and mental status and aid the Court in its decision as to whether to appoint Chris Ansman Successor Guardian. The Social Worker is allowed unlimited access to the Court file, may interview counsel for all parties, and interview Ward's parents, Patrice and John Hayes and Ward's spouse, Chris Ansman. The Social Worker is further ordered to file a report regarding her findings and opinion prior to the next hearing.

This is a final and appealable order.

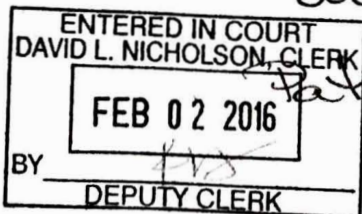
